QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a Board of Education Trustee if they meet the following criteria:

- Canadian Citizen;
- 18 years of age or older on voting day, November 4, 2023;
- Resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and,
- Not disqualified under the *School Act* or any other enactment from being nominated for, being elected to or holding office as a trustee, or be otherwise disqualified by law.



CAMPAIGN EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2023 General School By-Election, the expense limits for candidates during the campaign period is **\$5,398.92**.

THIRD PARTY ADVERTISING LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2023 General School By-Election, the third-party advertising limit is **\$809.84**.
