QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a School Trustee if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day, October 17, 2026;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified under the *School Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to, or holding office as a trustee, or otherwise disqualified by law.

CAMPAIGN EXPENSE LIMIT AND THIRD-PARTY ADVERTISING LIMIT

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general local election, the campaign expense limit for candidates is **\$6,161.89** and the third-party advertising limit is **\$924.28**.
